INT 84SB: "I crave your mouth, your voice, your hair": Love and Desire in Spanish and Latin American Poetry and Film Professor Silvia Bermudez - Spanish and Portuguese

In this seminar, we will first become acquainted with poems of love and/or desire from the Iberian Peninsula and Latin America spanning five centuries. We will then watch three films produced between 1990 and 2010. On the one hand, our aim is to understand how poetic discourse allows for the articulation of the variety of states, feelings and attitudes associated with passionate desire and/or romantic love. On the other, is to address how Latin American and Spanish filmmakers have addressed love and/or desire at the turn of the 21st-Century.

Professor Silvia Bermúdez teaches and researches on Iberian and Latin American Studies. Her current courses and research projects focus on Constitutional Spain, Latin American and Galician Studies, and Contemporary Spanish pop music.

How many "cancer breakthroughs" have you read about this year alone? How about advice about what to eat and drink or what to avoid? Should you take multivitamins and will Airborne really prevent you from getting a cold? Perhaps more importantly, should you have gotten that meningitis vaccine? How can you find out what to pay attention to and what is really just media hype? We will read, critique and discuss current literature in biomedical research that spawns news stories in the popular press. Students will identify and critique news media releases, popular science writing, and the primary research literature in an attempt to dissect the real science from the media (or advertiser) spin. The over-arching goal of the course is to increase biomedical research literacy at the level of the citizen-voter. Open to all upper division majors in the College of Letters and Science.

Professor Foltz teaches a variety of classes in MCD Biology and CCS Biology including Oncogenesis, Developmental Biology, Biomedical Research and a Cell Biology seminar. Her research is focused on the mechanisms of fertilization and essentially, how eggs turn into embryos.

This course is designed to provide students interested in a career in law and related legal studies with an introduction to the courtroom and lawyering before and during jury trials. Students will participate in an orientation session followed by off campus visits to the Santa Barbara courthouse. Students will observe attorneys at work in the courtroom, meet presiding judges and participate in trial planning and evidence presentation sessions with members of the public defender's office. Particular attention will be paid to effective communication and presentation skills useful for legal and other careers.

Daniel Linz is a psychologist in the Department of Communication who examines the social psychological assumptions made by the law and legal actors. His research and teaching spans the topics of: violence, pornography, pretrial publicity, news crime and race, attorney persuasiveness in the courtroom, police citizen interaction, and other legal topics.
